- 23 with data based on information reported through the Public
- 24 Education Information Management System (PEIMS) that enables an

- 2 (1) assess the impact of the program; and
- 3 (2) revise the program as needed to improve the design
- 4 and effectiveness of the program.
- 5 (c) The agency in coordination with the board shall solicit
- 6 input from educator preparation programs to determine the data to
- 7 be provided to educator preparation programs.
- 8 SECTION 3. Section 21.044, Education Code, is amended by
- 9 adding Subsections (c-2) and (f-1) to read as follows:
- 10 (c-2) Any minimum academic qualifications for a certificate
- 11 specified under Subsection (a) that require a person to possess a
- 12 bachelor's degree must also require that the person receive, as

- 1 face-to-face setting. The rules must permit each required formal
